## A MESSAGE

## FROM JOHN BREWER

Billings is Montana's City. This is where you come for business, for shopping, for great restaurants and entertainment. It's where you come to pursue your best life. We're doing well, but we believe it's time to supercharge our economic growth. Too often we hear about the blessing of Billings' slow and steady 1% growth—no doubt in deference to the wisdom gleaned from ancient fables. All due respect to Aesop, but a Billings hare would be swift and industrious, incapable of laziness and inaction.

Billings Chamber of Commerce members are in overwhelming agreement that reducing the cost of doing business in Montana generally benefits all Montanans. Regardless of political party affiliation and across industry sectors our members recognize that our business community is the generator of prosperity. Your Billings Chamber is here to make sure we have a business climate supportive of growth and profit.

Chamber membership has charged us with three top priorities: public safety, housing supply, and workforce attainment/readiness. These constitute our roadmap to success. If we can remove the roadblocks in the way of businesses and allow them to profit and prosper, we will invigorate growth and address many of the issues we face.

We've made major strides on those priorities in the last few years, but we're not done. More work remains to ensure criminals face appropriate and certain punishment for committing crimes like theft and domestic violence. Housing affordability will follow housing abundance, and we need to get onerous government regulations out of the way. We are rich in outdoor amenities, parks, and trails—attractions for the workforce we need—but will struggle with continued funding unless focus is returned to our core, and implementation of government efficiencies.

To address the challenges above, and ignite our economic growth, it will take more than Chamber staff. It will take our businesses, our elected officials, and the Billings community. This Public Policy Guide was developed to communicate our positions to that entire audience, and it will serve as our guide as we convene leaders to find solutions, champion our members at all levels of government, and find catalysts for growth. We look forward to working together to solve our challenges and work toward a brighter future for Montana's City.

# SMALL BUSINESS BILL OF RIGHTS

In a nation built by entrepreneurs and driven by free enterprise, small businesses should have the freedom to hire, innovate, grow, and strengthen their local economies and communities. We're calling on elected officials to foster their freedom to exist and thrive by upholding these basic rights for founders, entrepreneurs, and small business owners:

- I. The right to a competitive and available workforce.**  
Fueled by the energy and talent of workers, small businesses respond to the marketplace, meet customer needs, solve fast-changing problems, and foster dynamic and flexible workplaces. The government should advance policies that strengthen the workforce and help address the labor shortage, such as through legal immigration reform.
- II. The right to run a business free from government interference.**  
Small businesses are by necessity nimble, adaptive, and innovative. Heavy-handed regulations that put more business decisions under the control of the government undermines business owners' freedom and flexibility to run and grow their companies and serve their customers.
- III. The right to operate without fear of lawsuit abuse.**  
For a small business, one frivolous lawsuit can mean bankruptcy. Elected leaders must commit to clamping down on profit-based litigation and extortionary practices through commonsense legal reform.
- IV. The right to be rewarded for their hard work.**  
The promise of a profit rewards entrepreneurs' hard work and makes it possible to keep a business going. The government should not dictate how small businesses invest, direct, or share their hard-earned rewards or take a growing cut to fuel government spending.
- V. The right to take a risk.**  
Entrepreneurs, small business owners, and founders are among the most courageous in our economy—many put everything on the line in pursuit of an idea or a dream. Policies, rules and regulations that undermine competition and erode our free enterprise system threaten the risk-reward proposition that drives people to start, invent, solve, grow, and strengthen society.

# BUSINESS ISSUES

The Billings Chamber of Commerce supports policies that improve our business climate, promote a vibrant economy, and lead to a high quality of life. We believe that the private sector is generally more efficient than government, and government decisions should be made at the local level whenever possible. We support simplifying the tax code, diversifying revenue streams to alleviate property tax burdens, and broadening the tax base to keep rates low.

## We Support

- Efforts to reduce the cost of doing business.
- Continued tax simplification.
- Reducing unnecessary regulations that drive up the cost of doing business and implementing necessary regulations in a user-friendly fashion.
- Programs and resources that encourage entrepreneurship, new and existing business retention, and expansion.
- Multi-use development projects as a stimulus for economic growth, private investment and tourism attraction.
- A pattern of development that enables and encourages the most efficient possible use of taxpayer funds.
- Local option taxing authority as a mechanism for augmenting local revenues and reducing property tax.
- Creating new economic development tools to incentivize private investment and economic growth.
- Innovative funding and financing mechanisms.
- Open and fair trade policies that provide businesses broad access to markets.
- Utilizing tax increment finance funds for appropriate projects.
- Reforming liquor licensing laws in a manner that is equitable to existing license holders.
- The right of individuals to freely own, use and transfer real property with the ability to pass property from generation to generation without excessive taxation or penalty.

## We Oppose

- The removal or narrowing of existing economic development tools.
- Burdensome increases in the minimum wage.

# WORKFORCE & EDUCATION

As our business community thrives and grows, Billings must grow as well. We support policies that will help local businesses attract the talented workers they need to fill their vacancies and expand their operations. In the long term, our education system plays a critical role in readying the next generation citizens, workers, and business owners. We support policies that create a positive and effective learning environment for students at all levels.

## We Support

- Creating incentives to build more housing in Montana and removing barriers to development.
- Legal immigration that helps provide the talented workforce businesses need, while securing our borders.
- Cooperation between education institutions and businesses to facilitate internships.
- Efforts to improve education programs at all levels through choice, innovation, and quality assurance.
- Improving access to early childhood education and affordable childcare.
- Funding for pre-school, K-12 schools, career technical education, and higher education.
- Clean slate reforms to automatically expunge records of non-violent and low-level offenders who have fulfilled legal obligations without re-arrest or conviction.
- Eliminating tax on military retirement income to attract separated veterans ready to start a second career.
- Increased worker training through increased tax credits for apprenticeships and work-based learning, and state funded worker training programs.



# QUALITY OF LIFE

A strong business climate and a high quality of life cannot exist independent from one another; public safety, recreation opportunities, and other amenities are crucial for attracting the workers existing businesses need to grow as well as new businesses. We believe in policies that will make our community attractive to people regardless of race, sex, religion, sexual orientation, or gender identity/expression.

## We Support

- Continual evaluation of public safety spending to ensure efficient use of funds.
- Evaluating incarceration facilities to ensure adequate capacity for current and future needs.
- Adequate funding for parks, trails, and other amenities.
- Increasing cooperation between state and local governments to reduce crime.
- Policies and initiatives to reduce recidivism among those exiting incarceration.
- Increased oversight for sober living houses to ensure positive outcomes for residents.
- Efforts to distribute parolees equitably throughout the state.
- State reimbursement to local incarceration facilities for the full cost of housing state inmates.
- Efforts to combat human trafficking.
- Continued use of treatment courts and Motivated Addiction Alternative Program
- Innovation, cooperation, and funding to address homelessness, mental health, substance abuse, and addiction issues.
- Policies to create a welcoming community for a more diverse population that:
  - Prohibit discrimination in employment, housing, or public accommodation on the basis of race, color, religion or creed, national origin or ancestry, sex (including gender, pregnancy, sexual orientation, and gender identity), age, physical or mental disability, veteran status, genetic information, citizenship, or any other federally protected class.
  - Comply with existing federal/state law.
  - Do not create undue burdens on businesses.
  - Allow religious organizations to limit employment or give preference in employment to members of the same religion.

More than 2.6 million people visit Billings annually spending \$621 million every year (Destination Analysts). Bringing more guests to the state and community benefits all local businesses, supporting thousands of jobs and fostering economic growth. The Billings Chamber believes in policies that will help promote Montana, Billings, and Southeast Montana as tourism destinations, and allow businesses to reap the full benefits of those visitors.

## We Support

- State investment in a regional convention center in Billings, preferably in downtown, that would economically benefit a significant portion of Montana.
- Federal funding for National Parks infrastructure as a critical Montana tourism driver.
- Demand-generating infrastructure and programs to bring visitors, athletes, companies, and conventions to Billings while enhancing our quality of life as residents. These infrastructure amenities include public venues, natural, historic, and cultural amenities along with recreational trails.
- Efforts to ensure all publicly owned entertainment facilities are most effectively managed, providing exceptional quality of place, increasing non-resident spending, and using taxpayer dollars wisely.

## We Oppose

- Any reduction or reallocation of the funds generated by current Tourism Business Improvement District (TBID) laws.
- Any funding reductions to local marketing organizations such as tourism regions and Convention and Visitor Bureaus (CVBs).
- Any attempt to reallocate or increase the 4 % lodging facility use tax for purposes other than tourism promotion and tourism infrastructure unless a portion is also returned to tourism. The 4% general fund lodging tax should be allocated specifically to tourism promotion and local infrastructure.

# AGRICULTURE

Agriculture is the bedrock of our local economy, and it is an irreplaceable part of our history. Urban businesses in Yellowstone County succeed when rural ag businesses succeed. We believe in policies that give agricultural producers, and the businesses that support them freedom, access, and capital they need to thrive.

## We support

- Protecting senior water rights.
- Limited federal regulation over established navigable bodies of water.
- Management of wildlife at the state level of government, including sage grouse and predators.
- Trade policies that provide agricultural producers access to foreign markets.
- Increasing the ease of movement of agricultural commodities across state lines.
- Broad-based tax reform to make Montana more competitive for agricultural business investment and job creation.
- Funding and initiatives to expand meatpacking, processing, and rendering facilities.
- Efforts to increase livestock price discovery and competition.
- Preserving multiple use on public lands.
- Programs and initiatives that add value to local ag products.
- Funding for the development of rural infrastructure, such as roads, bridges, and rural broadband including 5G.
- Extension Service Programs continuing at or above current staffing and funding levels.
- Continued operation of Ag Research Stations at or greater than the current level of funding in order to attract and retain quality research and personnel.
- An equitable balance between the customer's right to repair and the rights of the manufacturer/dealer.

# HEALTH & WELLNESS

Quality healthcare is a prerequisite to a vibrant, healthy community. Pricing in healthcare should be affordable, transparent, and fair; bringing more market forces to the healthcare industry and allowing providers to adapt to new technologies will improve outcomes for everyone. We believe in policies that improve access to, and quality of care while encouraging patients to make better, more informed decisions.

## We support

- Continued and full funding of Medicaid Expansion.
- Stable and adequate local and state funding for community social service programs and facilities.
- Ongoing scrutiny, participation, and consideration of medical liability reform measures.
- Adequate reimbursement and expansion of tele-health services.
- Reducing barriers to accessing healthcare for patients and providers.
- Employer wellness initiatives encouraging personal responsibility and enhancing community health awareness.
- Mental health and suicide prevention, intervention, and treatment.
- The healthcare industry's right to determine the distribution of their community benefit funds at the local level.

# NATURAL RESOURCES & THE ENVIRONMENT

Montana is rich both in opportunities to extract the raw materials needed to fuel the economy and in natural beauty that attracts tourists and improves residents' lives. Finding ways to take full advantage of our natural resources while preserving the environment is key to our long-term prosperity. We believe in policies that allow Montanans to harvest resources and produce energy while preserving the environment for the next generation.

## We support

- The development of natural resources in a manner that is economically viable and environmentally sustainable.
- Maintaining and increasing Montana energy production, keeping energy affordable.
- Initiatives to ensure U.S. energy independence.
- Policies that encourage all forms of energy production, including reliable baseload power.
- The development of infrastructure projects to move energy resources safely and efficiently.
- Initiatives to allow stakeholders to vindicate legal rights without completely halting development.
- Exploring opportunities for expanding recycling services including public/private partnerships.
- Exploring opportunities to bring new green energy industries to Billings.
- Efforts to modernize and strengthen Montana's energy grid to improve reliability.
- Continued efforts to increase efficiency in City operations and pursue higher levels of LEED certification.
- Climate change policies that:
  - Utilize market forces to reduce greenhouse gas emissions.
  - Allow businesses and consumers flexibility in meeting targets.
  - Invest in new technologies.
  - Maintain energy reliability.
  - Give businesses long-term certainty needed to make rational decisions.
  - Address the problem at a federal and global level.

## We oppose

- Policies designed to slow or prevent the development of an innovative green energy business sector.

# INFRASTRUCTURE & TRANSPORTATION

Quality infrastructure provides businesses with access to markets and provides a foundation for development and expansion. In today's economy, internet connections are arguably just as important as asphalt. We support adequate funding, exploring new funding mechanisms, and a regulatory environment necessary to build a sustainable and resilient infrastructure system.

## We support

- Adequate funding for Montana's infrastructure improvements to keep pace with 21st Century business demands.
- Solutions to increase broadband and 5G connectivity.
- Regulatory reforms to reduce red tape that increases the cost of building infrastructure and delays projects.
- Legal reforms to prevent litigation from unduly delaying construction.
- Subdivision and zoning regulations that encourage efficient, practical development, while allowing flexible and innovative development strategies.
- Investment in a more diverse transportation system that provides viable choices to walk and bike, use public transportation, or travel by rail, in addition to driving.
- The continuation of Essential Air Service utilizing Billings as the hub.
- The growth and maintenance of air service in Billings, including revenue guarantees for expanding service.
- Maintaining the gas tax, which funds roads and bridges in Montana.
- An appropriate user fee for electric vehicles, commensurate with taxes paid by the average gasoline motorist, allocated to road maintenance.

# LEGISLATIVE

# PROCESS

- 1 Bill is introduced in House or Senate – chamber of origin (1st reading).
- 2 Bill is assigned to a committee.
- 3 Bill is heard in committee and (a) passes as is or with amendments, (b) fails by a vote of the committee, or (c) is denied a hearing.
- 4 Bill returns to the floor for potential amendments and engrossment (2nd reading).
- 5 Bill passes chamber of origin (3rd reading).
- 6 Bill repeats the process in second chamber.
- 7 If all these steps do not occur, the bill dies.
- 8 If bill completes process without amendment in second chamber, the bill is sent to the Governor.
- 9 If bill is amended in the second chamber, but its author and a majority of the chamber of origin approve the changes, the bill is sent to the Governor.
- 10 If the bill's author doesn't agree with the amendments, a conference committee is appointed.  
Conferees from both chambers negotiate changes to the bill – if they reach unanimous agreement on a conference report, the report passes the House and Senate Rules Committees and receives a majority vote in both chambers, the bill is sent to the Governor. If all these steps aren't successful, the bill dies.
